WHEREAS: The new York State Police and private fixed-wing aviation resources do not provide a medically trained team or medical equipment for patient transports; and

WHEREAS: The people of Clinton, Essex, Franklin, Hamilton and St. Lawrence Counties receive a vital emergency medical service which is free of charge to critically ill and seriously injured patients, and, therefore municipal governments are asked to pledge monies for this worthwhile program:

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the Town of Long Lake hereby authorizes the Supervisor to enter into a contract with North Country LIFE FLIGHT, Inc. For the purpose of operating the medical component of the medevac program, which will serve its residents and visitors, and paying the amount of \$2,000.00, which represents the Town's share for 2017; and be it

FURTHER RESOLVED: That the sum of \$2,000.00 is hereby appropriated for payment to Account No. A1010.4 for payment to North Country LIFE FLIGHT, Inc.
