6. Notice of Public Hearing on Local Law #1 of 2012 for Town of Long Lake.

Proposed Local Law No. 1 of 2012: A Local Law to Override the Tax Levy Limit Established in General Municipal Law §3-c.

PLEASE TAKE NOTICE that A Local Law entitled: "Override of the Tax Levy Limit Established in General Municipal Law §3-c for the Town of Long Lake, Hamilton County for Fiscal Year 2013" has been introduced before the Town Board of the Town of Long Lake, Hamilton County and State of New York pursuant to Subdivision 5 of General Municipal Law §3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board. This action will allow the Town Board to adopt a budget for town purposes for the fiscal year 2013 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

PLEASE TAKE NOTICE that a Public Hearing upon said proposed Local Law #1of 2012 will be held at the Raquette Lake Union Free School, Raquette Lake, New York on the 14th day of November 2012 at 7:30 PM Eastern Time and that an opportunity to be heard in regard thereto will then and there be given to those favoring passage of such proposed amendment and also to those opposed thereto. At such time and place all persons interested in the subject matter thereof will be heard concerning the same.
