1. Spring Clean-up Service Policy

2015 Town of Long Lake Spring Clean-up Policy for Long Lake and Raquette Lake from May 4th to May 18th , the Requester of service will agree to:

1. The Town of Long Lake is not responsible for any damage to his/her property incidental to the request, and
2. All service requests are for trash or other such materials as may fit in a single pick-up truck load (ex. old mattresses, furniture, metal, appliances), and
3. The Town will **NOT** pick up leaves, lawn clippings or brush; bagged or otherwise, and
4. The removal of junk cars and/or boats is limited to two items, and
5. Town Employees are not required to gather or pile the requested materials, and
6. The Town Employee's only requirement is to pick up and remove the materials described by the owner, and
7. All trash, etc, shall be assembled at the curb or driveway edge for convenient removal, and
8. Mandatory Recycling and Waste Disposal Rules Apply

2. Resolution to Support Adirondack Lakes Center for the Arts

WHEREAS: The Adirondack Lakes Center for the Arts (ALCA) is a not-for-profit, tax-exempt corporation which provides arts and cultural services including music, dance and theater performances, workshops and classes in the visual and performing arts for all ages, exhibits by regional and national artists, artist's residencies in schools, and

administration of the New York State Decentralization Re-grant Program for Hamilton County; all services being available to the residents and visitors of the Town of Long Lake, and

WHEREAS: ALCA requires donations and support to operate and provide their services,

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the Town of Long Lake hereby authorizes the Supervisor to enter into a contract with ALCA to provide the amount of \$3500, and

FURTHER BE IT RESOLVED: that the sum of \$3,500 is hereby appropriated in the 2015 Budget Account No. A1010.4 for payment to the Adirondack Lakes Center for the Arts.
