Whereas the Landfill Closure Capital Project was established August 25, 1999 for the purpose of recording project financing and expenditure of funds to comply with NYS DEC Order on Consent to permanently cease the disposal of solid waste at the Long Lake Landfill, and

Whereas the closure was 90% funded by the Bond Act which funds were applied for and received from the NYS Environmental Facilities Corporation CWSRF, and

Whereas the \$111,386.24 currently held in the HDC capital project represent un-disseminated Bond Act reimbursement receipts for force account work performed by the Town of Long Lake, and

Whereas this capital project has been completed since 2006, the only related work currently being done is post-closure monitoring which costs are not considered part of the capital project, and

Whereas the NYS Office of the State Comptroller has stated the town needs to close this project,

Now Therefore be it resolved that the Landfill Closure capital project be closed, and that the \$111,386.24 held in the HDC capital project money market account be transferred to the General Fund and the Water District #2 Fund as follows: \$110,735.36 to General and \$650.88 to Water District #2.

4. APPROVAL FOR TRANSFERS

5. Budgetary Amendment Resolution for Decentralization Grant Receipt

WHEREAS, the Town of Long Lake Parks, Recreation and Tourism Department applied for funding from a Decentralization Grant which is administered by the Adirondack Lake

Center for the Arts, and

- WHEREAS, the Town was awarded a grant in the amount of \$4,500 to be used for the "Portraits of the Wilderness" outdoor art installation beginning in June by Matt Burnett, and
- WHEREAS, the Town was given an additional \$500 which will be used again for Matt Burnett's outdoor art installation, and
- WHEREAS, the receipt and expenditures of such grant funding requires an amendment to the Town of Long Lake 2014 Budget,
- NOW THEREFORE BE IT RESOLVED that the Town Board of the Town of Long Lake gives approval to increase the Parks and Recreation Revenue account A2001 by \$500 and the Other Culture & Recreation Expenditure account A7989.4 by \$500.
