1. Budgetary Amendment to Receive Snowmobile Trail Development and Maintenance Cost Assistance

WHEREAS, the Town of Long Lake is dedicated to the provision of snowmobile recreation which provides a significant boost to the local winter economy, and

WHEREAS, the Town can apply for snowmobile trail development and maintenance cost assistance from the New York State Office of Parks, Recreation and Historic Preservation, said funding being derived from snowmobile registration fees and a high snow allowance which are paid to grant recipients in 70% + 30% increments each year, and

WHEREAS, the total amount applied for is intended to cover 13 miles of the B.R.A.S.S. grooming contract fees along the rail corridor and the remainder for routine trail maintenance costs of another 57 miles, and

WHEREAS, the Town has received the 30% increment for the 2014-2015 season which is \$14,175, and

WHEREAS, \$14,175 of the amount received exceeds the 2015 Long Lake Budget and the receipt and expenditure of such State Aid grant requires an amendment to the 2015 Budget,

NOW THEREFORE BE IT RESOLVED, that the Long Lake Town Board gives approval to

increase the General Fund Revenue Account A3889 by \$14,175 and the General Fund Appropriation Accounts A7260.1 and A7260.4 by \$7,087.50 each in the 2015 Budget.

2. Resolution to Enter into Contract with North Country LIFE FLIGHT Inc.

WHEREAS: North Country LIFE FLIGHT Inc. is a not-for-profit, tax-exempt corporation which is responsible for all aspects of patient care by providing medical equipment, training medical personnel and administering the medical portion utilizing the New York State Police helicopter based in Saranac Lake and private fixed-wing aviation resources; and

WHEREAS: The new York State Police and private fixed-wing aviation resources do not provide a medically trained team or medical equipment for patient transports; and

WHEREAS: The people of Clinton, Essex, Franklin, Hamilton and St. Lawrence Counties receive a vital emergency medical service which is free of charge to critically ill and seriously injured patients, and, therefore municipal governments are asked to pledge monies for this worthwhile program:

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the Town of Long Lake hereby authorizes the Supervisor to enter into a contract with North Country LIFE FLIGHT, Inc. For the purpose of operating the medical component of the medevac program, which will serve its residents and visitors, and paying the amount of \$2,000.00, which represents the Town's share for 2016; and be it

FURTHER RESOLVED: That the sum of \$2,000.00 is hereby appropriated for payment to Account No. A1010.4 for payment to North Country LIFE FLIGHT, Inc.
