Supervisor Arsenault began the workshop with public comment from Caleb Davis.

Mr. Davis asked the Board to consider budgeting for "bear proof" trash cans that can be placed on or around the Town Beach area.

Supervisor Arsenault said he has been researching "bear proof" trach cans and said they are very expensive, but he would like to get the expert opinion from the DEC Wildlife biologist about the effectiveness of the trash cans.

Supervisor Arsenault informed the Board the 2023 fiscal budget is currently \$58,243/3.5% over the tax cap.

Employee health insurance had an increase of 9.1% Town Insurance/ General Liability increase of 6% Cyber Insurance increased by 150%

Supervisor Arsenault asked the Board what their thoughts were of budgeting \$10,000 for new addition to the Archives building.

The Board was not in favor of budgeting \$10,000, for the addition all agreed that the Town should be looking into digitizing all records.

Central Data Processing 1680.2 & 1680.4

\$40,000 was added to the budget to build a server, update cables and modernize the entire system.

\$20,000 was added for ongoing IT support. The Town is waiting on final quotes for the last two items. ARPA fund balance will be utilized for the \$40,000.

A 20% increase has been added to Public Bathroom Cleaning, Medical Building Cleaning.

Bus Reserve 5630.21

\$5,000 is budgeted for a new Town of Long Lake bus.
