# **SUPERVISOR'S REPORT**

Expenditure & Revenue reports were in the Board's packets.

NYS DOT, Scott Stearns has been contacted by Matt Newby with the Town of Long Lake's concerns of the retaining wall at the Town field. Mr. Stearns was reminded that NYS DOT Commissioner Marie Therese Dominguez and Region 2 Director Linda Lubey said the issues would get fixed when they visited in July after the flood. Mr. Stearns has sent the project up the chain of command to increase visibility.

The Reiss family wrote a letter to NYS DOT Region 2 about the speed limits in the Hamlet of Long Lake. Supervisor Arsenault thanked them for their tenacity in writing the DOT, and hope that more people do the same.

The Town has received the Pre-Review Comment Form for the TAP-CMAQ-CRP grant application. The award will not be announced until June 2024, the State-Local Agreements will not be finished until December 2024, it is recommended to hold off on the design process until January 2025.

Organizational meeting for the Town of Long Lake will be held January 3, 2024, at the Long Lake Town Hall at 7:00pm.

The Raquette Lake Historian, Joanna Nelson has submitted her letter of resignation. Letters of interest and qualifications will be accepted in January 2024.

Water system inspections from NYS Department of Health Engineer, Marlene Martin were included in the Board's packets. The inspection noted that increased storage for Raquette Lake is a must, which will be discussed with Town Engineer Firm CHA.

Mountain Abstract is still working through historical records to determine the ownership and rights to the causeway of Jennings Park Pond.

Engineered design and plan estimated cost will be around \$850,000, just the design would require the second biggest bond the Town has ever had. The Town could go through the process of design, incur that debt, and still have DEC, APA, Comptroller's Office, environmentalists, and any number of other unknow factors stop the project. Bond Counsel search has started, which will be needed no matter what route is taken.

If the causeway can be rebuilt, it will need to be to current codes and standards, and likely move the most vulnerable point of failure to the Route 30 causeway. This point will be pressed with the NYS DOT to work with the Town to fortify their structure, while also improving parking and pedestrian safety.
