RESOLUTION #2 OF 2024

Resolution to Approve Vector One IT Solutions Recommended IT Improvement Project

WHEREAS, The Town Board approved a contract with Vector One IT Solutions to provide the Town with IT services; and

WHEREAS, Vector One IT Solutions has provided the Town Board with their recommendations to build the Town network and server infrastructure to better serve the needs of the Town and improve cybersecurity for Town operations; and

WHEREAS, the Town received \$66,191.00 in State and Local Recovery Funds during the COVID pandemic and the Town Boad decided to apply these funds to the cost of IT Infrastructure; and

WHEREAS, the Town budgeted \$71,600.00 in 2023 for IT Equipment and Services; and

WHEREAS, IT Infrastructure expenditures which are eligible for ARPA funds to be used totaled \$10,173.81 in 2023, leaving a balance of \$56,017.19 of those funds; and

WHEREAS, the Vector One IT Solutions project quote is for \$27,932.75 to build out the IT infrastructure including \$15,548.75 for hardware and \$12,384.00 for contractual expenses not including travel expenses;

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Town Board accepts the recommendation and quote from Vector One IT Solutions dated November 21, 2023 for \$32,360.00 to build a server and extend the Town network to three additional locations; and
- 2. That the Town Board appropriates \$20,000.00 to budget line A00-01-1680-200 for equipment, and \$16,000.00 to budget line A00-01-1680-400 for contractual expenses, with those funds to be taken from ARPA funds held in General Fund fund balance.
