# Dogs-

The Supervisor's Office has been inundated with complaints of dog droppings being left on Town Properties. It is ILLEGAL for people to leave dog droppings on any other property than their own, they MUST be picked up and disposed of properly.

Another issue that has been brought to the Supervisor's Office is Town officials and employees having their personal pets at their Town workplace or in Town vehicles. The Town's insurance agency advises that officials and employees should NOT be allowed to have personal pets at the workplace or in Town vehicles. Supervisor Arsenault suggested a policy be drawn up and be discussed at May's meeting.

# Medical Building Plumbing Updates-

Chad had worked with BJ Queen's crew from April 18<sup>th</sup> to April 22<sup>nd</sup>, rebuilding the plumbing.
