WHEREAS, on account of revised Department of State Requirements to submit only a complete text of the local law being amended or revised and not just the amending language, and

WHEREAS, notice of said public hearing was duly advertised in *The Hamilton County Express*, a weekly newspaper and the official newspaper of said Town, on October 8<sup>th</sup>, 2025, addressing the amending language only, and

WHEREAS, notice of said public hearing was posted at various locations within the Town and made available on the Town's public web site, and

WHEREAS, said public hearing was duly held on Wednesday, October 29<sup>th</sup>, 2025, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Local Law, or any part thereof, and

WHEREAS, the public was invited to submit any written comment prior to board action to consider the proposed law, and

WHEREAS, pursuant to 6NYCRR Part 617 of the implementing regulations pertaining to article 8 State Environmental Quality Review Act (SEQRA) it has been determined by the Town Board that adoption of the proposed Local Law would not have a significant effect upon the environment and is exempt from further environmental review pursuant to 6 NYCRR Section 617.5 (c)(20) as a "routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment" and could be processed by other applicable governmental agencies without further regard to SEQRA, and

WHEREAS, the Town Board of the Town of Long Lake, after due deliberation, finds it in the best interest of said Town to adopt said Local Law.

**Resolution for the Adoption of the 2026 Grade and Wage Program Policy**

WHEREAS, the Town of Long Lake has historically utilized a Grade/Step system to determine new hire wages and wage progression for municipal employees; and

WHEREAS, the Town Board has reviewed and approved a new Grade and Wage Program Policy designed to simplify wage administration, improve flexibility in setting new hire wages, and ensure fairness and transparency in employee compensation; and

WHEREAS, the new policy replaces the previous Grade/Step and Longevity systems, and establishes clear procedures for determining new hire wages, annual increases, cost-of-living adjustments, and performance-based promotions; and

WHEREAS, the policy includes defined responsibilities for the Town Supervisor, Department Heads, and the Business Office, and outlines a structured performance review process to support wage recommendations; and

WHEREAS, the Town Board has approved the inclusion of this new Grade and Wage Program in the Fiscal Year 2026 Town Budget, and intends for the policy to take effect on January 1, 2026;

**NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Long Lake**

1. hereby formally adopts the Grade and Wage Program Policy, Policy Number EH601, as the official compensation framework for Regular Full-Time and Part-Time employees of the Town, effective January 1, 2026.

2. **BE IT FURTHER RESOLVED**, that the Town Supervisor, Department Heads, and Business Office are directed to implement the policy in accordance with its terms, and that all future wage determinations and performance evaluations shall be conducted pursuant to the procedures outlined therein.

### **Resolution 63 of 2025**

#### **Resolution Authorizing Execution of Agreement with Tri-Lakes Humane Society for Dog Shelter Services**

WHEREAS, the Town of Long Lake is required under New York State Agriculture and Markets Law to provide appropriate shelter for dogs seized or quarantined under Article 7 of said law; and

WHEREAS, the New York State Department of Agriculture and Markets has recently imposed more stringent and costly requirements for municipal dog shelter operations, following incidents involving mass casualties at private boarding facilities; and

WHEREAS, the Town of Long Lake has historically sheltered dogs briefly while the Dog Control Officer attempted to locate the owner, and has utilized the Tri-Lakes Humane Society for long-term sheltering when owners could not be located; and

WHEREAS, in response to the new regulatory requirements, the Town has arranged to immediately transfer all seized dogs to the Tri-Lakes Humane Society upon capture, thereby expanding the scope of services provided under the existing relationship; and

WHEREAS, the Town Supervisor has executed a new agreement with the Tri-Lakes Humane Society dated October 7, 2025, to formalize this expanded arrangement, covering the period from October 1, 2025 through December 31, 2025, at a cost of \$250.00; and

WHEREAS, the Town Board wishes to formally authorize the Supervisor's execution of said agreement;

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board of the Town of Long Lake hereby authorizes and ratifies the execution by the Town Supervisor of the agreement with the Tri-Lakes Humane Society dated October 7, 2025, for the provision of dog shelter services in accordance with the terms set forth therein.
